GENERAL INFORMATION

- a) Gates will be open from 12:30 on Friday, please do not arrive before them as we have much work to do readying the venue for your arrival. Sound Test & Scrutineering do not open until 16:00.
- b) Please follow the route to RAF Marham shown on the attached map. Enter via Crash Gate 5 and turn immediately right and follow route which will be arrowed, please bring only one service vehicle per competing car into the service area to minimise congestion, trailers should be left in the designated trailer park area.
- c) On unloading your car, proceed to Noise Check and Scrutineering. DO NOT FORGET to affix numbers to the FRONT DOORS of your car (numbers are on sale at Signing-On). Late numbers in the queue for Scrutineering MUST, if instructed by an Official, make way for early numbers. Early numbers are nevertheless instructed to arrive early and must not assume they will be allowed to queue-jump should they arrive late.

4 SCRUTINEERING / SOUND TEST

a) Sound Test & Scrutineering

Friday 12th August 16:00 - 20:00

Saturday 13th August 07:00 - 09:30

b) NOISE: Ensure that your car meets the MSA regulations of 100 dB(A) (see SR9). You will not be allowed to start if it fails the initial noise test or any subsequent checks made throughout the day.

5 SIGNING-ON

a) Signing-On

Friday 12th August 16:00 - 20:15

Saturday 13th August 07:00 - 09:45

- **b)** We ask all competitors to arrive at Signing-On FULLY PREPARED WITH ALL PAPERWORK; items will be checked in the order shown on your process sheet. Please ensure that you arrive in plenty of time.
- c) You MUST be signed-on at least 30 minutes before your due start time.

6 COMPETITION NUMBERS:

A limited supply of numbers will be on sale at signing-on, cost 50p each.

7 ACCESS & SPECTATING

You will find enclosed 3 vehicle passes for your use (Competing Car, Service Vehicle and Ancillary), see SR12(f)), please do not forget these as they will be required to enter the venue. Please be aware that you will be required to stay within the Service & Spectator area for the duration of the weekend (not including crews competing on a stage), see SR12(a) unless you are staying off site or you are using the Bus facility for Spectating (See Below). This area will be patrolled by Military Police and anyone found breaking this rule will be penalised accordingly. The Vehicle with the "Ancillary" pass (excluding motorhomes) must park in the Spectator Car park.

The Service Area is not adjacent to the Stages this year, however we have arranged for some Buses that will be running in a loop to the 3 spectator areas we have. Your Service Crew are welcome to use these to see your progress. Please ensure they have their wristbands on or you may not be allowed back into the Service Area.

The gates to the venue will be locked overnight between 22:00 (23:00 on Saturday) and 07:00. Toilets and showers are available and are marked on the attached diagrams

8 SECURITY WRISTBANDS

All Competitors and Service Crew will be expected to wear a Security Wristband during the duration of the event, you will be supplied with 2 Competitor Wristbands and 6 Service Crew Wristbands when you sign on. If you need more please ask. It is your responsibility to ensure all your crew and any associated personnel have these on at all times. If Security find any person without these wristbands they are likely to be ejected from the site.

9 PENALTY MARKERS

Competitors are reminded of SR24. Penalty markers will consist of barrels, cones and other suitable media and penalties will be fairly applied from written reports from Judges of Fact. We are sure that neither you the Competitor nor we the Organisers want the event to be delayed while the artificial scenery is either repaired or replaced. It is for this reason that the penalties are applied.

Competitors are also reminded of SR12(b) and SR12(c) the requirement to follow the route as defined on the stage maps and course markers. There is extensive airfield equipment remaining in-situ (lighting, signage etc) which may be concealed by stage equipment and will be required to function immediately after the event. To minimise the possibility of damage to this equipment anyone violating these regulations will be penalised accordingly.

10 CAMPING

Camping is within the Service Area and is available to all Competitors, Officials and Marshals on Friday & Saturday nights. Please camp on the grass adjacent to your service area. Do NOT use up service area hard standing for camping unless absolutely necessary.

11 DRIVING STANDARDS

You are reminded of the 10 mph speed limit that is in force on all roads on RAF Marham (other than live Special Stages) and that the Road Traffic Act also applies (including alcohol limits). Military Police will be present throughout the whole event.

12 PACE NOTES

Competitor are reminded that Pace Notes are not permitted on Multi Use Stage Events. Ensure you are fully aware of the regulations and penalties for the possession of such notes. R24.7.5, R29.1.7 and R41.4.3. Checks will be made on the event and anyone in possession of such notes will be reported the MSA.

13 FRIDAY NIGHT ENTERTAINMENT

There will be a BBQ with Burgers & Hot Dogs and a Bar adjacent to Rally HQ on the Friday Evening starting at 19:00.

14 PARTY ON THE PAN

Tickets will be issued to the competing crews as part of their competitors packs at signing-on (2 free). A limited number of additional tickets will be available for purchase from the Helpdesk in Rally HQ at the same time for £10 each (£5 for under 16's) (cash only), which includes 1 free drink & food item and a live band. Please purchase additional tickets as early as possible to avoid disappointment.

15 AUCTION

At the Party on the Pan we will be having an Auction to raise additional money for the Charities. If you have any items you can donate to the auction please either contact Chris Daykin on 07779 239182 or bring them along with you.

How to get to RAF Marham




RAF Marham is located about 6 miles West of Swaffham, just off the A1122 Downham Market to Swaffham Road.

Please only approach the venue from the A1122, this is part of a Traffic Management plan to ensure we do not bring congestion and disturbance to Local Residents.

From the A1122 take Chalk Lane to the North, signposted Narborough. The entrance to the venue is approx 400 yards after leaving the A1122.

Approach routes will be signed.
















MSA Service Area Guidelines

Entrants, competitors and service crew members should be aware of their own and other people's safety and well being, when competing in motor sport.

- 1. All competitors must have an environmental ground-sheet in place before work commences on the vehicle.
- 2. All service vehicles must have an environmental spill-kit, for use in the event of liquid spillage. Competing cars must also carry such a kit, see MSA Regulations for definition.
- 3. Fire extinguishers should be readily available at all times when vehicles are to be worked on, particularly in the event of any welding or grinding being carried out and when vehicles are being refuelled.
- 4. Vehicles should be supported by axle stands, chassis sill stands or ramps, all with recommended base plates, when raised in the air by trolley or any other types of jack. Engines should not be run when the vehicle is raised on stands. No other work on the car should be attempted, when raising or lowering of the car is taking place.
- 5. If re-fuelling is permitted in the Service Area, this should be the last operation to be carried out before the vehicles leave. The vehicle should be off any support stands, have all four wheels on the ground, have all other work ceased and have no occupants, when re-fuelling commences. Ideally re-fuelling should be by hand pumping, rather than from hand held containers.
- 6. Spillage of any liquid should be contained immediately by the crew concerned.

A) Storage & Use of Petroleum Spirit

- 1. Containers should comply with the relevant British Standard, should be marked "Petroleum Spirit-Highly Flammable" and be kept from any source of ignition.
- 2. All empty containers should be removed from the venue after the event.
- 3. Petrol is to be used as fuel only, not for any other purpose.
- 4. All vehicle re-fuelling is to take place in the open air. A "No Smoking" area should be enforced and an operative should be on standby with a fire extinguisher.
- 5. Refuelling operatives, including those standing by with fire extinguishers, should ensure they are wearing protective clothing, including gloves and eye protection.

B) Hazardous Substances

- 1. Some vehicle parts, for example brake & clutch linings, contain asbestos. Competitors are encouraged to use non-asbestos substitutes where possible. Where asbestos is used, every effort should be made to prevent dust being released.
- 2. Some mineral oils may cause skin cancers. Where contact does occur, contamination should be washed off immediately. The wearing of any contaminated clothing should be avoided.
- 3. Other substances may cause ill health. Suppliers will have information about the possible effects of their products, on request.

C) Electrical Safety

- 1. All electrical equipment should be maintained in a safe condition.
- 2. Extension leads & cables should be neoprene, oil resistant flexible cable.
- 3. All electrical equipment used externally should be weatherproof and tools should be "double" or "all insulated" against electric shock.
- 4. Electrical equipment and hand tools should not be used where flammable vapours are present.

D) Fire Precautions

- 1. All competition and service vehicles should carry a suitable fire extinguisher.
- 2. Special consideration should be made before lighting any cooking appliance.
- 3. All sources of ignition should be kept away from any fuel store or re-fuelling area.
- 4. Fire extinguishers should not be moved from their known location, other than when in use.
- 5. In the event of any fire, a report should be made to the organisers of the event before leaving the venue.
- 6. All competitors are encouraged to train their personnel in correct fire prevention and treatment procedures.

E) Compressed Air Equipment

- 1. Air blasts from over inflated tyres can cause severe injury. Tyres should not be inflated above manufacturer's recommendation figures.
- 2. Always stand clear when inflating tyres.
- 3. Compressors & air lines should be inspected regularly.
- 4. Compressed air cylinders should be stored and used to supplier's recommendations.

F) General Working Practices

- 1. All working areas should be kept clean & tidy. All waste & spillage should be cleared up immediately, removed by the competitor at the end of the event and disposed of in a responsible manner.
- 2. Trailing cables & hoses should not be allowed to create a trip hazard and should not be run across access or roadways.
- 3. Whenever vehicle engines are being run, adequate ventilation must be in place.
- 4. All safety notices should be complied with.
- 5. Any personnel carrying out work should ensure that they adopt safe working practices at all times.

- 6. Service crews and competitors need to be aware of the long periods of exposure to cold, wet or heat, experienced while on location in service areas and dress accordingly.
- 7. Children under 16 years of age are to be closely supervised and should not leave your designated area unaccompanied.

 They are children and as such are your responsibility!!

G) Noise

- 1. Exposure to excessive noise may result in hearing loss, or other complaints. These may be short term, or after prolonged exposure, permanent.
- 2. Where exposure to noise is unavoidable, ear defenders should be worn.

H) Manual Handling

1. Lifting, carrying and propelling of loads by bodily force is a major cause of industrial injuries. All competitors are encouraged to train their personnel in safe manual handling techniques.

I) Waste

1. Competitors should remove all waste from the venue, including containers, packaging, tyres, oils etc. They must be disposed of in a responsible manner.

J) Vehicle Safety

- 1. A 10 mph speed limit should be observed at all times in a Service Area, other than for Emergency Vehicles which may be attending an incident.
- 2. There may be pedestrians in Service Areas. Special care must be taken in these circumstances, to avoid collisions.
- 3. The unauthorised use of mopeds, motorcycles, scooters, go-peds, quads etc. is forbidden in Service Areas.
- 4. Vehicles may only be driven by persons holding valid driving licences for that class of vehicle.

K) First Aid

1. Any person sustaining injury or illness, should seek treatment from the event emergency services, by initially reporting to the Senior Official in charge of the Service Area, who will ensure the appropriate response.

L) Public Safety

1. Competitors and their associated personnel should act in a manner so as not to put either themselves or any other person at risk of injury.

M) Reporting of Accidents & Incidents

1. All accidents where any person sustains injury, or where damage to property occurs, should be reported immediately to the Senior Official in charge of the Service Area.

N) Further Regulations and Information

1. Competitors are reminded of their obligations to comply with the requirements of the appropriate sporting regulations at all times. These Guidance Notes should be read in conjunction with all relevant regulations.
